PROVINCIAL INCENTIVE PROGRAM

Do you have a Registered Disability Savings Plan?
If so, you would also qualify for the Provincial Incentive Program.

The Provincial Incentive Program (PIP) provides Registered Disability Savings Plan (RDSP) holders with a **one-time \$150 stipend** for their RDSP account as a means of helping grow financial security for persons with disabilities.

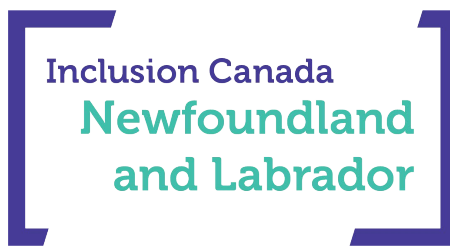
Administered by the Inclusion Canada Newfoundland and Labrador, the PIP is easy to apply for. Simply fill out this application form and send it to Inclusion Canada Newfoundland and Labrador along with a copy of your Contribution Acknowledgment Form. (You can get this from your bank or financial institution. It lists the name of the RDSP holder, the beneficiary, and the RDSP account number).

Upon approval, the stipend cheque will be sent to the financial institution for deposit into the person's RDSP account.

What you need to do:

1. Set up an RDSP through a bank, financial institution, or investment group.
2. Complete the form on the back of this page and send it to the following address:

3. You **MUST** include a copy of your **Contribution Acknowledgement Form**, which can be obtained from the bank where you set up your RDSP.
4. You will receive a letter and a phone call from Inclusion Canada Newfoundland and Labrador when it is processed.
